TERMS AND CONDITIONS

In consideration of the covenants contained here, the owner, _____ I/C No. _____ of Vehicle No. _____, leases to the undersigned Renter, upon the terms, covenants, terms and conditions set out herewith, the motor vehicle described above, referred to as vehicle.

- (1) Renter acknowledges that the vehicle is the property of owner and that he or she has received it in excellent mechanical and body condition. The scratches/damages as of this dated contract are as follows:

- (2) Renter agrees that he or she will return the vehicle to the owner's station from which it was rented (unless agreed with the owner), in the same condition as he or she received it, on the return date, time and place stated above. The renter agrees to indemnify the owner at a rate of \$100 per hour (or pro-rated accordingly) if the car is returned later than the agreed time above. This also applies in the event that the collection time is later than the agreed time above.
- (3) In the event of an accident or any damage that warrants repair, Renter agrees to indemnify the owner for loss of usage at a rate of \$200 per day in addition to the cost of repair and spare parts. The rate is applicable from the date that the vehicle is sent to the workshop and must be paid by the Renter to the owner on a recurrent and weekly basis (\$1400) or within 3 working days from the date of completion of repair, whichever is earlier.
- (4) Renter further expressly agrees to indemnify the owner for any and all loss(es), damage(s), cost, fine(s) or expenses e.g, traffic fine paid during the times and dates of rental. The deposit \$300 will be held for 10 working days upon return of the car. This is to allow deduction from the deposit for any and all loss (es), damage(s), cost, fine(s) or expenses e.g., traffic and/or parking fine made known and sent to owner by the relevant body e.g, HDB Traffic Police. Should the deposit be insufficient to cover the cost of fine(s) and/or cost of repair, the deficit will be recovered from the Renter. As such, the Renter must pay the owner within 2 working days of the issuance of fine(s) from the relevant said body or invoice from the workshop/parts supplier.
- (5) As the vehicle will come with a full tank of petrol, the renter expressly agrees to return the car with the fuel tank full. Failing which, the renter will pay the owner a sum of \$100 which is deductible from the deposit.
- (6) Renter expressly agrees to pay owner on demand:
 - (a) A sum equal to the cost of all damages to the vehicle during this rental period provided, however, that Renter's liability shall not be limited. The cost of damage will be ascertained by the owner's preferred and authorized workshop.

(b) A sum equal to the value of all tires, tools and accessories lost, damaged or stolen from the vehicle.

(c) A sum of \$50 for each key lost.

- (7) The vehicle shall only be driven by the named driver above at all times and cannot be driven outside of Singapore.
- (8) Should the vehicle breakdown or malfunction during the period of rental, it is sole responsibility of the Renter to tow the vehicle or take the necessary action to prevent any traffic offence and/or obstruction. The owner will not held liable or responsible in anyway for any mechanical problems and/or mishaps that could happen to the Renter and/or vehicle during the rental period. Hence, the Renter is advised to conduct a thorough check of the vehicle during the test drive and also prior to handover.
- (9) In the even of theft or a serious accident which renders the vehicle completely useless or incapable/ non-viable to repair, the Renter agrees to reimburse the owner the full value of the vehicle within 5 working days from the date of this agreement. This is solely determined by the owner and agreed upon the Renter in this agreement and is independent of any reference or guide. Vehicle no. _____ is currently valued at \$ _____.
